The topic of the thesis is very actual. I have to admit that this is a very demanding topic. I have to commend the student for the overall processing of this diploma thesis. This objectives can be considered as fulfilled.

The work is divided into 6 chapters and in the first three parts focuses on the introduction, theoretical findings and literature research and research methodology. The remaining three chapters devote themselves to the results of their own study on the subject. With regard to the complexity of the topic, the work is done in a good way. Some targets are treated rather superficially, but in view of their nature, they could not be dealt with in more detail because they lack the necessary data from the market. In his conclusions, the student draws on a literature search rather than on his own research, but it could have been assumed in terms of the subject of work. That is why I lower the rating of this diploma thesis.

I have some serious objections against the formal quality of this diploma thesis. The master thesis is written in good English, is logically structured and is followed by the list of references, but contains small stylistic nuances, as well as shortcomings in the occasional non-compliance with rules of technical writing. However, these facts do not reduce the quality of this thesis. From the point of view of the content, the thesis is very sophisticated. Collaboration with the student for the preparation of her final work was very good. The diploma thesis meets the requirements of the final thesis of this type and I therefore recommend it for the defence.
