The thesis introduces a topical issue of the workplace diversity, which becomes more and more important for the managers, employees and organisations and their success both in the Czech Republic and worldwide. The theses is logically structured and in the theoretical part, the author uses relevant sources. However unfortunately the author does not use any of the sources originally planned in the Master Thesis Assignment Form. There are described dimensions of the diversity, its challenges and benefits.

I appreciate the application of the issues from the theoretical part into the environment of the chosen company and collecting of the primary data. The topic of the workplace diversity in KFC is analysed there based on the survey carried out among the employees of one branch of the KFC company as well as random respondents via social networks both in English and Czech language. Key findings from this survey are presented (and statistically evaluated) in the thesis and proposals are based on these findings. Moreover, the student tries to bring an economic evaluation of proposal for the selected company.

The formal part of the thesis is the biggest weakness. Thesis contains many formal shortages and does not respect all requirement of the directive of the Dean No. 1/2019 on Bachelor Thesis and Master Thesis at the Faculty of Economics, Technical University of Liberec as was recommended by the supervisor.

The references are not according to the citation style ČSN ISO 690 used in this directive; they are also not in the alphabetic order, page margins are not of the correct size etc. The text does not refer to all figures and tables, only some of them. Sources from the list of the specialised literature from the Master Thesis Assignment Form are not cited in the thesis. The author talks e.g. about research paper however, the text is a diploma thesis (master thesis). The work also contains other formulation inaccuracies. The Application of academic sources in native language, including bibliographic references and citations is not relevant to evaluate (the thesis is written in English and applied in the environment of the Czech branch of KFC company).

Despite these extensive formal shortcomings, I evaluate the diploma thesis overall as "very good", especially with regard to the content processing of the thesis, the preparation of the questionnaire (both in English and Czech language) and the collection and processing of the data including the proposals.
