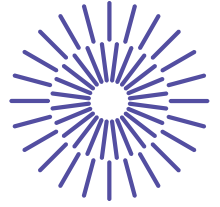

# 1 Introduction

These guidelines contain translation of the book *Metodika citování, 3. vydání* [1] which is based on the currently valid Czech citation standard *ČSN ISO 690:2022 Informace a dokumentace — Pravidla pro bibliografické citace a citace informačních zdrojů* [2] as well as the original English standard *ISO 690:2021 Information and documentation — Guidelines for bibliographic references and citations to information resources* [3]. During the update of the Czech citation standard, numerous notable modifications have been implemented, encompassing terminology adjustments, limitations on typographic methods in bibliographic citations, and the expansion of rules governing the citation of electronic sources [2]. This book does not apply all the rules of the new citation standard; it applies those rules that are desirable at the Technical University of Liberec. Individual faculties further adapt the rules according to their needs in the guidelines for thesis writing [4].

The most important changes in this manual compared to the previous publication *Metodika zpracování bibliografických citací a pravidla pro psaní citací, 2. vydání* [5] are as follows:

- An in-text citation that points to a source of information in the body of the paper is now called shortly a ‘citation’.
- Instead of a maximum of three authors, the reference lists five authors; the abbreviation et al. is applied from six authors onwards.
- Words indicate the volume and issue of journals; the distinction in bold or brackets is not used.
- New types of information sources extend the guidelines according to the needs of the Technical University of Liberec, e.g. software and datasets.

When referencing, it is crucial to follow the rules below:

1. Adhere to a consistent citation style, format and punctuation throughout the work. Citation styles cannot be combined.
2. Identify information taken from other works (quotations or paraphrases) in a clear and distinct way.
3. Provide enough information in reference to make the cited source clearly identifiable and traceable.

4. Cite non-public sources (interview, email, etc.) only if the information cannot be found in publicly available information sources.
5. Check the accuracy of data obtained by the programs and correct errors according to the primary information source.

There are a number of tools—reference managers—that allow you to work more efficiently with sources of information and to cite in your own work. We can recommend Zotero [6], JabRef [7], and citace PRO [8]. References created using reference managers do not currently apply all the rules of ISO 690:2022 and the regulations mentioned in these guidelines.

Some examples have been changed from the original Czech version [1] to illustrate the topics in English better.

In line with current requirements, we note that an artificial intelligence tool, the GrammarlyGo plugin, was used to formulate some of the sentences in this translation. ChatGPT and Perplexity were used to check grammar and find some examples of references.

## 2 Quotation and paraphrase

Utilizing information sources involves examining the views of individual experts and comparing their agreements and contradictions. The citation rules are essential and form the basis of academic ethics and copyright law.

When citing, three parts are included in the paper: the quotation or paraphrase, the reference and the citation (formerly an in-text citation). The information taken can be used in the text as a quotation or paraphrase. The list of references consists of bibliographic references of individual information sources. The citation provides the connection between the information taken and the bibliographic reference.

### 2.1 Quotation

In the quotation, the entry in the text is taken exactly as it appears in the original document. A quotation is written in italics and in quotation marks. The text is transcribed verbatim, and no part of it may be omitted<sup>1</sup>. The quotation shall indicate the pages of the original document on which the entry appears if the original document is paginated. Examples of quotations are given below.

#### **Example 1 – name and date system**

*‘During the birth of bioethics from 1947 to the 1970s, nurses’ voices were left out of the dialogue of ethics’ (Butts and Rich, 2020, p. 60).*

#### **Example 2 – numeric system**

*‘It is important to call a client by the name he or she prefers’ [2, p. 11].*

### 2.2 Paraphrase

In the case of a paraphrase, the information is given in its own words, without italics. Paraphrases shall not be written in quotation marks, indicating the pages are unnecessary.

The original wording of the information used in examples 1 and 2 can be verified in chapter [2.1](#).

**Example 1 – name and date system**

Between 1947 and the 1970s, nurses were not included in ethical discussions related to the development of bioethics (Butts and Rich, 2020).

**Example 2 – numeric system**

Always address the client by their preferred name [2].

## 3 Citation

For each quotation or paraphrase in the text, the citation shall be created to the list of references used so that the source of the cited information can be accurately identified. Thus, a citation is a reference in the written text to another source of information, or part thereof, made by one of the systems described in the chapters 3.1 to 3.5.

Different citation systems are preferred in different disciplines. The following systems can be recommended for specific disciplines:

- architecture: name and date system,
- economics: name and date system,
- engineering: numeric system,
- medicine: name and date system or numeric system,
- pedagogy: name and date system,
- textile: name and date system.

The Technical University of Liberec's name and date system uses round brackets, while the numeric system mostly uses square brackets.

### 3.1 Name and date system (Harvard system)

In the name and date system, the year of publication is moved to after the authors' names in the reference list for all bibliographic citations. If a source does not have an author, [ANON.] is used instead. If multiple sources have the same author and year, lowercase letters are added after the year to differentiate them (NOVÁK, Richard et al., 2020a; followed by NOVÁK, Richard et al., 2020b and so on).

In the citation, the authors' last names, the year including a distinguishing letter and, in the case of quotation, the page number is included, e.g. (Pokorná et al., 2019) or (Košta, 2013, p. 54). If the author's surname appears in the text, it is suppressed in the citation, and only the year is given with the page cited, if any (e.g. According to Kapounová (2020), about half a million Europeans suffer a cardiac arrest every year.).

If multiple sources of information provide identical information, the text will include the citations in consecutive single brackets, separated by a semicolon, i.e. (Novák, 2016; Procházková et al., 2017, p. 54).



**Citation to an information source without author:**

(Anon., 2016)

**Citation to a single-authored information source:**

(Košta, 2013)

**Citation to an information source with two authors:**

(Novák and Procházka, 2022)

**Citation to an information source with more than two authors:**

(Svoboda et al., 2021)

When a multi-author citation is truncated and matches another citation, the surnames of the additional authors are included until there is a distinction in the citation. For example

(Svoboda, Novák and Malý, 2021)  
(Svoboda, Novák and Zelený, 2021)

In the reference list, references are arranged alphabetically from A to Z, then chronologically for identical authors, and then alphabetically by title.

### **3.1.1 Example of text and reference list**

Valuable data was in the publication *Transcultural Concepts in Nursing Care* (Andrews and Boyle, 2016). According to Kapounová (2020), major health-care-associated infections can be influenced through prevention. ‘*During the birth of bioethics from 1947 to the 1970s, nurses’ voices were left out of the dialogue of ethics*’ (Butts and Rich, 2020, p. 60).

Tomšej (2020b) gives an example of when employees may lie to their employer about their health. Even so, there are occupations where an employee’s health is a prerequisite for doing the job. If an employee’s health prevents them from performing such a job and the employee is judged to be unfit, this is not discrimination on the grounds of health (Tomšej, 2020a). According to § 62 of the Higher Education Act (Czechia, 1998), the protection of student health is also necessary during university practice.

## 3.2 Numeric system

Numerical citations are written in the text from number 1 upwards, i.e. in the order in which they are first cited. Numbers should be given in round or square brackets or superscripts; at the Technical University of Liberec, using square brackets is recommended. It is possible to refer back to previously mentioned literature, but it is necessary to keep the number of the source used (e.g. 1, 2, 3, 4, 2). Non-consecutive numbering (e.g. 1, 5, 3, 4) is prohibited.

When creating a paragraph, gathering information from various documents and compiling them into one paragraph with citations listed at the end is inappropriate. Each quoted text must be accompanied by its corresponding source citation directly after. The references list should be arranged in ascending numerical order. If multiple sources contain the same information, they should be cited in the text within one parenthesis and separated by a comma, e.g. [1, 4].

### 3.2.1 Example of text and reference list

Valuable data was in the publication *Transcultural Concepts in Nursing Care* [1]. ‘*During the birth of bioethics from 1947 to the 1970s, nurses’ voices were left out of the dialogue of ethics*’ [2, p. 60]. Measuring temperature in the ears using a specialized digital thermometer is a recent advancement [3]. According to § 62 of the Higher Education Act [4], the protection of student health is also necessary during university practice.

### 3.3 Named tag system

The author creates a distinctly named tag for each source of information, which is included in square brackets before the reference in the reference list. Citations are formed using these named tags, written in round or square brackets or as superscripts. The reference list is organized alphabetically based on the named tags. If multiple sources contain the same information, all corresponding named tags are listed consecutively in the text (e.g. [POIUZ] [TREWQ]).

#### 3.3.1 Example of text and reference list

Valuable data was in the publication *Transcultural Concepts in Nursing Care* [TCINC]. ‘*During the birth of bioethics from 1947 to the 1970s, nurses’ voices were left out of the dialogue of ethics*’ [NE, p. 60]. Measuring temperature in the ears using a specialized digital thermometer is a recent advancement [VVOPONDPS]. According to § 62 of the Higher Education Act [ZOVŠ], the protection of student health is also necessary during university practice.

## 3.4 Running notes (footnotes system)

Continuous citations are written in the text from number 1 upwards, i.e. in the order in which they are first cited. These citations can be enclosed in round or square brackets or in superscripts immediately following the referenced information. Using non-consecutive numbering such as <sup>1, 5, 3, 4</sup> is not permissible. If a source is cited more than once, a new number should be assigned to it in the text.

It is impossible to create a paragraph by taking information from different sources, writing it out in one paragraph, and putting all the citations at the end. The citation to the source used must be given directly after the quotation or paraphrase.

When multiple sources of information share identical information, their respective citations should appear consecutively and be separated by a comma, e.g. (<sup>3, 4</sup>).

A footnote is created on the same page as the cited information. The text of the footnote may contain the full reference or a shortened form in the format SURNAME OF THE FIRST CREATOR, *Title*, year, page number (for example NOVÁK, *Fyzika*, 2023, p. 57) or for multiple creators SURNAME OF THE FIRST CREATOR et al. (e.g. (MAGERČIAKOVÁ et al., *Motivace sester po pandemii covidu-19*, 2023, p. 14).

The reference list is arranged in ascending order by number. If any information source is cited more than once, the complete reference is written for the first digit; for the others, only the first surname, the digit of the first reference, and, if necessary, the page for the quotation is written (e.g. KAPOUNOVÁ, note 2, p. 65.).

### 3.4.1 Example of text and reference list

In the publication *Transcultural Concepts in Nursing Care*<sup>1</sup> a lot of valuable information is mentioned. Major healthcare-associated infections<sup>2</sup> can be influenced through prevention. Measuring temperature in the ears using a specialized digital thermometer is a recent advancement.<sup>3</sup> ‘*During the birth of bioethics from 1947 to the 1970s, nurses’ voices were left out of the dialogue of ethics.*’<sup>4</sup> According to § 62 of the Higher Education Act<sup>5</sup>, the protection of student health is also necessary during university practice.

## 3.5 Implied system

The implied system can be used for citing standards, which always have their own unique designation using standard numbers. Citations are made up of standard numbers. References also begin with the standard number. The reference list is arranged alphabetically according to the first element.

### 3.5.1 Example of text and reference list

ETSI EN 301 549 V2.1.2 defines an authoring tool as software that can be used to create or modify content. On page 14 of the standard ČSN ISO 690:2022, the term database is defined as ‘*sbírka (3.6) strojově čitelných informací uspořádaných tak, že mohou být snadno zpřístupněny, spravovány a aktualizovány*’ (a collection (3.6) of machine-readable information arranged so that it can be easily accessed, managed and updated). The standard ČSN EN 12464-1:2022 defines only two terms: place of the activity, or the submission of the shape; modelling.

## 4 Secondary referencing

Secondary referencing or citation of citation is the citation of an information source that cites another information source. This method of citing is not recommended. The original source of information should always be traced, and the information cited should be verified in that source. Secondary citation is only possible in exceptional cases.

It is important to indicate in the citation that the information cited is from a secondary source and to identify the original author properly. Only the secondary source should be listed in the reference list, while an original document that was not consulted should not be included [9].

### 4.1 Name and date system

## 5 Principles of references

The individual data elements used in reference for the description of the information resource (hereinafter metadata) are primarily taken directly from the cited document in the following order: title page or its equivalent (title screen, etc.), embedded or external metadata (source code, etc.), cover, case, accompanying documentation (user manual, etc.), web page source code. Library catalogues and electronic databases (secondary metadata sources) are mainly used to verify the accuracy of the metadata or to track down missing metadata.

Metadata taken from secondary sources or added by the author of the citation is given in square brackets, e.g. [\[viewed 2023-01-30\]](#).

When multiple variations of a particular data exist in the information source, the predominant form or the one validated by secondary sources is utilized.

Metadata has a fixed order and method of writing according to the chosen citation style.

The principle of preserving spelling standards applies, i.e. the spelling rules of the specific language in which the metadata is written are followed.

The principle of language preservation also applies, i.e. individual metadata is used in the original language, not translated. For example the title of the Czech book remains [Osudy dobrého vojáka Švejka](#), the name of the French publisher [Hachette Livre](#), the Czech edition in the book written in the Czech language is [2. vyd.](#)

For papers from conference proceedings, a reference is created either according to the template for a book chapter (applies to one-off conferences) or to the template for an article (applies to repeated conferences).

### 5.1 Creators

The creator of the information source can be a person or a corporation (companies, institutions, conferences, etc.). While tools powered by artificial intelligence (AI) like ChatGPT, DALL·E, Midjourney, and Lumen5 cannot be cited as authors or co-authors in references, it is necessary to acknowledge their utilization in work itself, typically in the introduction or methodology section.

The **names of the persons** are given as they appear in the cited information source. In the case of different variants of a name in individual references, a uniform form of the name shall be used in all references so that all works of the same author use the same creator information (e.g. [ROWLING, J. K.](#) and [ROWLING, Joanna K.](#)

and ROWLINGOVÁ, J. K. are unified as ROWLING, J. K.)<sup>1</sup>. All authors' surnames are capitalized. Academic titles are not given. **First names** are written as they appear in the information source, e.g. JAROŠOVÁ, Darja and Renáta ZELENÍKOVÁ. All first names that appear in the document are given. If the author's initial is given instead of the full first name, it is followed by a full stop, e.g. VOLANDES, A. E. All author initials are given, e.g. PURKYNĚ, J. E.

When there are one to five authors, all of their names are listed (such as BRDLÍK, Pavel; Jan NOVÁK; Martin BORŮVKA; Luboš BĚHÁLEK and Petr LENFELD). However, if there are six or more authors, only the first five are listed, and the remaining authors are abbreviated with **et al.** (e.g. HLAVÁČKOVÁ, Veronika; Rojina SHRESTHA; Eva HOFMANOVÁ; Pavel KEJZLAR; Jakub ŘÍHA *et al.*). There is no comma before *et al.*

The **names of the editor(s)** are followed by the abbreviation (ed.) (e.g. DAVIDSON, Ronald J. (ed.) or MAREŠOVÁ, Vilma and Pavla URBÁŠKOVÁ (ed.)).

When citing an **organization**, as the author, use its official name written in capital letters (e.g. TECHNICAL UNIVERSITY OF LIBEREC). If the organization has a commonly known abbreviation, it may also be used but must be included in the list of abbreviations. (For example, if the author of the cited source is the World Health Organization, it can be abbreviated to WHO in the reference).

If the information source has no creator, then

in the name and date system, the named tag system and the implied system, the abbreviation [Anon.] is written instead of the creator,

in the numeric system and the running notes, it is simply excluded without any replacement. The reference starts with the name of the information source.

## 5.2 Titles

The information source's title is italicized. If there are multiple titles, the title of the parent unit is italicized. For example, if an article from a journal is cited, only the title of the journal is italicized. Likewise, if a book chapter is cited, the book's title is italicized. When citing a webpage, the website's title is italicized.

The title also incorporates the number and title of the volume, and these meta-data are also written in italics (e.g. *Vnitřní lékařství. I. díl*).

If a question mark or exclamation mark is part of the title, it must also be included and the full stop after it is omitted (e.g. *Chcete se dostat na lékařskou fakultu?*).

The subtitle, i.e. the information supplementing the title (e.g. *Alergie: léčba a odstranění příčin alergických reakcí*), is not obligatory, but since it has considerable informational value, it is recommended to include it in the reference.

## 5.3 Formats

For non-print sources of information, it is mandatory to indicate the format (e.g. [PDF](#), [MP4](#), [EPUB](#), [programme](#), [video](#), [dataset](#)) and the type of medium on which the information resource is available (e.g. [online](#), [CD-ROM](#), [cassette tape](#)). For traditional printed sources, these metadata are not given.

## 5.4 Edition and version

The first edition is not indicated; in other cases, the edition is mandatory. Abbreviating the edition is recommended (e.g. [3. vyd.](#), [2. rozšíř. vyd.](#), [V MKP 3. el. vyd.](#)).

The edition is given in the language of the information source, i.e. it is not translated into Czech ([2nd ed.](#) for English source, [5.](#), [neu bearb. Aufl.](#) for German, [26ème éd.](#) for French etc.).

Information about the version is always given (e.g. version of the article before peer review [Preprint](#), online version of an article prior to its inclusion in the printed version of the journal [Online first](#), standard in progress [Draft](#), software version [Version 2.4](#), dataset version [Version 1](#)).

## 5.5 Series

Series is a publisher's collection to which the cited information source belongs, e.g. series [Sestra](#) of the publisher Grada. The series title is often mentioned on the document's cover or on the page opposite the title page. In English, it often contains the word 'series'. Individual documents belonging to a series may be numbered. It is recommended to add the title of the series and the number into reference; the information is taken from the source cited (e.g. [Edice moderních švýcarských autorů, vol. 8](#)).

## 5.6 Place and publisher

If more than one place of publication is mentioned in the information source, only the first place of publication, i.e. the city, is always written. The metadata is given as it appears in the cited source of information (e.g. [Praha, V Liberci](#)). State names or abbreviations of U.S. states are not provided.

Only one publisher's name is given; in the case of multiple publishers, the name of the first publisher is given. The metadata is copied as it appears in the source of information; it is not abbreviated (e.g. [Vydavatelství Univerzity Palackého Olomouc](#)). The company form (for example s. r. o., a. s., Ltd.) is omitted.

When the location or publisher information is not provided, it is omitted from the reference.

## 5.7 Year or date

The year or date of publication shall be written as it appears in the document cited; it should be written in Arabic numerals.

For printed sources, only the year of publication is used (e.g. 2023).

When the source of information only provides the year of copyright instead of the year of publication, it should be recorded along with the copyright symbol © (e.g. © 2021).

When citing electronic sources, the full publication date is included, if available (e.g. 22 May 2019). The full date shall be followed by the formalised form of this metadata in the format [YYYYY-MM-DD] (e.g. the date 31 January 2023 is written as [2023-01-31]). In cases where it is also necessary to indicate the time when the information source was published (for interviews, social media posts, etc.), it should be written in the form [YYYY-MM-DDTHH:MM] (e.g. time 14:20, date 31 January 2023 should be written as [2023-01-31T14:20]).

The date of citation is given only for dynamic documents<sup>2</sup>. It is written in the form [viewed YYYY-MM-DD] (e.g. [viewed 2023-01-31]). For static documents<sup>3</sup>, the date of citation is not included.

## 5.8 Volume and issue, or date

In periodical publications, the sources used are identified by volume and issue number or by date of publication. In the case of both variants, only the volume and issue number are used. This information is always abbreviated in the language of the cited source (e.g. the quoted Czech article will have metadata *roč. 18, č. 2.*; English article will be cited using metadata *vol. 2, no. 5*) see table 5.1, which contains a list of abbreviations in the most commonly used languages. The date shall be written in the formalised form YYYY-MM-DD.

## 5.9 Pagination

In references of sources that are parts of other information sources (e.g. journal articles, conference proceedings, book chapters), the location of the source is mandatory. The page range is given (e.g. pp. 33–58 or p. 67).

In other cases, the number of pages is not mandatory, and it is recommended not to specify.<sup>4</sup>

## 5.10 Identifiers

Only one identifier or standard number of the information source is given in the reference.

The priority of identifiers or standard numbers is determined as follows: DOI, ISBN<sup>5</sup> (only if DOI is not available), ISSN (if ISBN is not available), then ISAN, ISMN, ISRC, ISRN, ISWC, PMID, arXiv ID and any other identifiers.

The persistent identifiers DOI, HDL (Handle), URN, PURL and ARK are given as hyperlinks in the reference section Availability and location according to the following scheme:

Available from: routing service/identifier (e.g. Available from: <https://doi.org/10.1016/j.cej.2017.07.132>).<sup>6</sup> The URL of the information source is not included in the reference.

## 5.11 Availability

A complete hyperlink is given (a full URL, e.g. Available from: <https://portal.liberec.cz/>); Internet applications serving to shorten URLs are not used.

When dealing with dynamic web pages that may not be preserved in their original form, it's advisable to create an archive of the referenced web page to ensure its availability in the future<sup>7</sup> and in the reference provide a reference to the archived version (e.g. Archived copy available from: Internet Archive (distributor), <https://web.archive.org/web/20230211163257/https://www.fm.tul.cz/pro-uchazece>. [archived 2023-02-11]. [viewed 2023-02-11].).

If the information source has a persistent identifier, that identifier replaces the URL; see section 5.10.

## 5.12 Location

The information about location shall be provided for internal and company information sources that are not freely available (e.g. `At: internal document from Magna company`). For rare information resources that are available only in a specific library (manuscripts, printed qualification works, etc.), the name of the library and the signature or other location data are given so that the information resource can be traced (e.g. `At: Moravian Library, call number Moll-0006.028`).

## 7 Common typographical errors

When citing a source, it is paramount to adhere to the proper typographical conventions applicable to the language used. Other resources on this topic can be recommended, particularly, *The complete manual of typography* [13] and *Merriam-Webster Dictionary and Thesaurus* [14].

### 7.1 Two full stops in a row

If two full stops occur consecutively in a reference (e.g. when using *et al.* or *ed.* or other abbreviations), only one full stop is always written.

### 7.2 Line-breaking points

If an ISBN, ISSN, or DOI number appears at the end of a line, it should not be split into two lines. Instead, nonbreaking hyphens and nonbreaking spaces are used.

Similarly, it is not recommended to split numerals, dates or copyright symbol © followed by the year at the end of a line; again, a nonbreaking hyphen or nonbreaking space should be used.

Long URLs can be wrapped after a period, colon, single or double slash, hyphen and other non-alphabetic graphic characters (i.e. after . or : or / or // or - etc.).

## 7.3 Capitalization of titles

It is recommended to write capital letters in titles (i.e. title, subtitle, series title) in English language sources. Similarly, the subtitle after a colon should begin with a capital letter. Principal words like nouns and verbs are capitalized, while articles and short prepositions are not capitalized unless they are the first word.

Capitalization should be consistent throughout the document.
